By this Deed you agree (and, if relevant, agree to allow Your Child) to take part in the Activity/Performance and agree to grant to SCA and its Related Bodies Corporate (as defined in the *Corporations Act 2001* (Cth)) the right to record (both audio and visual) and take photographs of You/Your Child (the "Recordings") in connection with the Activity/Performance.

You warrant that you have the right to enter this Deed and that You:

1. are 18 years of age or older and (if relevant) are the parent or legal guardian of Your Child;
2. agree that SCA, its Related Bodies Corporate and/or any other affiliated bodies (the "Authorised Entities") may use, edit and reproduce, and authorise the use, editing and reproduction of the Recordings;
3. agree that the Authorised Entities have the right to publish, broadcast and/or communicate to the public the Recordings in any media including, but not limited to, television, print, radio and/or online, at all times without restriction or limitation throughout the world (including for all promotional purposes);
4. agree that the Authorised Entities have the right to use Your and/or Your Child's name, likeness, biography or other information concerning You or Your Child in relation to the Recordings;
5. agree that SCA or another of the Authorised Entities owns all rights, title and interest (including copyright) in the Recordings and You and Your Child expressly assign to such entity any rights You or Your Child may have in the Recordings;
6. consent to the Authorised Entities doing all of the things outlined in this Deed, even if those things would otherwise infringe Your or Your Child's moral rights;
7. agree to fully release now and forever the Authorised Entities from and against all actions, suits, claims and demands which You and/or Your Child may have against any of them arising directly or indirectly in respect of any infringement

or violation of any personal and/or property rights of any sort (including without limitation defamation) from the use of the Recordings;

8. unconditionally waive all of Your and Your Child's rights at any time to seek or obtain injunctive relief to prevent or restrict use of the Recordings by any of the Authorised Entities;
9. warrant that Your or Your Child's performance will not be defamatory, fraudulent, deceptive or misleading, generally offensive or a breach of confidentiality or breach of any person's privacy rights;
10. undertake that Your or Your Child's performance will be original and You acknowledge that the Authorised Entities are not obliged to actually use the Recordings;
11. acknowledge that neither You nor Your Child are due any fee for the Performance or for any future use of the Recordings;
12. agree to keep the terms of this Deed (and any information under or resulting from it) confidential and not to disclose them to any third party without the consent of SCA except where required by law or for the purpose of confidential consultation with your legal or financial advisors;
13. agree to take (and procure Your Child to take) any further steps reasonably requested by SCA to give effect to this Deed; and
14. have read and understood this Deed and are aware that by executing this Deed, You are waiving certain legal rights (including the right to sue) which You or Your Child, heirs, next of kin, executor, administrators and assigns may have against the parties who benefit from the terms set out in this Deed.
